

Can the Netherlands' solar sector be rebuilt?

The Netherlands' solar sector is not characterised by its size and can only be rebuilt by relying on European collaboration. The scenario analysis demonstrates that a subsidy of about 5 cents/Wp is required for European-made PV panels to compete with other global PV manufacturers.

Are photovoltaic modules tax-free?

Who supervises the financial markets in the Netherlands?

Dutch market financial supervision is carried out by: The Netherlands Authority for the Financial Markets (AFM), which supervises the conduct of the financial markets. A single Euronext Rule Book governs trading on all Euronext Securities and Derivatives Markets. It contains both harmonised and non-harmonised, or local, rules.

Who regulates a regulated market in the Netherlands?

Operation of a regulated market in the Netherlands is subject to prior licence. This licence is granted to Euronext by the Dutch Minister of Finance.
