What happens if a battery is exported?

Producer E declares batteries placed on the market and puts them into stock. Some of these batteries are then sold to an export customer by producer E. As long as the export takes place during the same compliance period that the batteries were reported as placed on the market, company E can deduct the exported batteries from their batteries data.

## Can I deduct exported batteries from my report?

Compliance schemes must not provide batteries data where producers have estimated the amount of batteries they have exported. Examples of evidence include invoices and bills of lading. You can then deduct these batteries for the data you report. Here are 4 examples of when you can deduct exported batteries from your reported data.

What is extended producer responsibility for batteries & registration obligations?

Extended producer responsibility for batteries and registration obligations already exists in the EU battery directive. Extended producer responsibility means that companies that first make batteries available on the market in a member state are responsible for the end-of-life collection and treatment of the batteries in that member state.

How does the Environment Agency collect and review batteries data?

Which company imports and sells batteries?

Company Fimports batteries, declares the batteries placed on the market in 2018 and puts them into stock. Some of these batteries are then sold to company G, who exports the batteries in January 2019.

Are portable batteries taxable in the UK?

This change took effect in January 2019. The Batteries Regulations 2009 were amended to allow producers and compliance schemes to deduct portable batteries they export outside the UK from their reported batteries data.
