How many shipments of solar energy equipment have been seized?

U.S. Customs and Border Protection has seized 1,053 shipmentsof solar energy equipment between June 21,when the Uyghur Forced Labor Protection Act went into effect,and Oct. 25,it told Reuters in response to a public records request,adding none of the shipments have yet been released.

Why are Xinjiang solar shipments piled up at US ports?

More than 1,000 shipments of solar components worth hundreds of millions of dollars have piled up at US ports since June under a new US law banning imports from China's Xinjiang over concerns about so-called " forced labor " Reuters reported, citing US customs officials and industry sources.
