Why are Chinese solar panel manufacturers seeking a government intervention?

REUTERS/Stringer/File Photo Purchase Licensing Rights SHANGHAI, June 12 (Reuters) - Chinese solar panel manufacturers said they are seeking immediate government intervention to curb investment and industry collaboration to arrest a plunge in prices of solar cells and modules, as the industry faces overcapacity.

Will China become the world's largest solar panel manufacturer?

Financial incentives and a government push have helped China become the solar panel factory of the world, accounting for about 80% of global module capacity. Analysts expect Chinese manufacturers to add up to 600 gigawatts (GW) this year, enough to meet global demand through 2032.

Why did Chinese media scold the solar industry?

The strains were apparent in Yibin, a city in southwest China known for its spicy cuisine and fiery baijiu liquor. The CPIA hosted a meeting there with Chinese media in which it scolded reporters for focusing on negative news and implored them to help promote the sector. Solar companies are used to more positive coverage.

How many solar panels have been cancelled in China in 2023?

Between June 2023 and February 2024, at least eightcompanies cancelled or suspended more than 59 GW of new production capacity, equivalent to 6.9% of China's total finished panel production capacity in 2023, according to the China Photovoltaic Industry Association (CPIA).

Will China's solar industry get quotas?

The firms will receive quotasfor how much they can produce next year, based on their existing market share and capacity as well as expected demand, according to local media. The CPIA declined to comment on the agreement. The accord comes as China's solar industry contends with overcapacity, heightened geopolitical tensions and slowing demand.

Can solar quotas succeed in a fragmented and competitive industry?

It's too early to tellwhether quotas can succeed in such a fragmented and competitive industry. But what's clear from comments made by solar executives at two high-profile events last week -- the BloombergNEF Summit in Shanghai and the China Photovoltaic Industry Association's gathering in Yibin, Sichuan -- is the desperation behind the move.
