Per the above, the Appellant submits that in the instant case where the contract is awarded as a whole for supply of solar power generating system consisting of various components (as highlighted above) as well as services, the entire contract should qualify as supply of solar power generating system taxable at the rate of 5%.

If the supply of Solar Power Generating System is to be treated as work contract, the same would be taxable as -General Construction Services of power plants and its related infrastructure with SAC Code 995426 with effect from 28.06.2017.
