What happens if a battery is damaged on an EV?

'On EVs the battery can, in effect, form part of the chassis, so if there is serious structural damage it might mean the car is written off. However, we know that Ford, GM and others are working on repairable battery packs.

What is stranded energy in electric vehicle batteries?

In post-crash situations,passengers,bystanders,and first responders are exposed to the immediate safety risks of stranded energy in electric vehicle (EV) batteries. Reusing a battery from an EV that was in a collision requires mechanics to check the battery's diagnostic data to make sure it's functional and safe-- and Tesla doesn't let third parties look at that date.

Can EV batteries be recycled?

"We've seen a really big shift and it's across all manufacturers," he said. There are currently no EV battery recycling facilities in the UK, forcing salvage companies to store the batteries from written-off cars in containers.
